Dear Mr. Horn:

The City of Carpinteria is submitting a request to amend Title 14 (Zoning) of the Carpinteria Municipal Code (CMC) and the City's certified Local Coastal Program to replace the City's existing CMC §14.59- Medical Marijuana Dispensary Regulations with new comprehensive Personal Use and Commercial Cannabis Regulations. The proposed regulations would regulate personal use cannabis cultivation throughout the City and provide limited allowances for commercial cannabis distribution, manufacturing, analytical testing, and non-storefront retail delivery uses in the City's Industrial Research Park (M-RP) zone district.

The City's current moratorium prohibiting all commercial cannabis activities throughout the City will expire on May 8, 2019. It is our goal to have the proposed LCPA certified by the Coastal Commission, and adopted and effectuated by our City Council prior to the expiration of the moratorium.
