## TRANSPORTATION PERMIT STANDARD CONDITIONS

1. The hauling vehicle shall not pass through the City of Carpinteria between the hours of 7:00 A.M. and 9:00 A.M. and 4:00 P.M. and 6:00 P.M.
2. The hauling vehicle shall use the approved oversize load transportation routes listed below:  
  
**Southbound 101 Route** – Exit Carpinteria Avenue and travel south, approximately 3.5 miles. Turn left at Rincon Road/SR 150/US 101 bridge interchange. Turn right onto US 101 on-ramp and continue south.  
**Northbound 101 Route** – Exit SR 150/US 101 interchange. Turn left at Rincon Road and continue toward coast. Turn right at Carpinteria Avenue and continue through town. Turn right at Santa Ynez Avenue. Turn left at Via Real and continue to Santa Monica Road. Turn left onto US 101 on-ramp and continue north.
3. Permittee shall notify the City of Carpinteria at least twenty-four (24) hours prior to the time the hauling vehicle will travel through the City of Carpinteria by calling (805) 684-5405 ext. 445.
4. Permittee shall defend, indemnify and save harmless the City of Carpinteria, its officers, agents and employees from any and all claims, demands, damages, costs, expenses (including attorney's fees), judgments or liabilities arising out of this permit or occasioned by the performance or attempted performance of the provisions hereof; including, but not limited to, any act or omission to act on the part of the or his agents or employees or other independent directly responsible to him; except those claims, demands, damages, costs, expenses (including attorney's fees), judgments or liabilities resulting solely from the negligence or willful misconduct of the City.
5. Permittee shall provide proof of liability insurance in an amount not less than \$1,000,000 per occurrence for vehicular and bodily injury claims and naming the City of Carpinteria as an additional insured on a separate endorsement (ISO form CG2012 or equivalent). The policy or policies shall also contain a provision that no termination, cancellation, or change of coverage for the insured or additional insured shall take effect until ten (10) days notice has been given in writing to the City of Carpinteria. An insurance rating with a current A.M. Best's rating of no less than A:VII will be accepted.
6. Permittee shall notify the City of Carpinteria immediately in the event of any accident or injury arising out of or in connection with this permit.
7. Permittee shall abide by all City, State, and Federal Laws, Rules and Regulations applicable to this activity.
8. This permit shall be carried in the vehicle to which it refers at all times while the vehicle is within the City of Carpinteria limits.
9. The City of Carpinteria reserves the right to modify, suspend, or revoke this transportation permit at any time.
10. This permit is valid only within the limits of the City of Carpinteria. Applicants are responsible for any and all other permits from other agencies and/or municipalities while transporting oversized loads.
