

# PARTY JUMPERS PERMIT

*El Carro, Monte Vista, Memorial and all other City parks*

Parks & Recreation Department: 805-755-4416 or 755-4432 (weekends: 755-4413)

**Policy:** The use of inflatable jumpers at all City parks must be approved and permitted by the City of Carpinteria. All permit holders and jumper companies must abide by the following rules:

1. The City charges a \$10.00 Jumper Permit application fee which is charged to the renter.
2. **USE AT YOUR OWN RISK.** Jumpers are used at the sole discretion of the user. **The City accepts no liability for any bodily injury or damage to personal property.**
3. At El Carro Park, all jumpers are to be set-up in the grassy area between Sites #2 and #3. **The use of a generator is prohibited in this park only.** An electrical outlet is available for use on the wooden enclosure adjacent to this designated area. At other parks, please be considerate of the neighbors and the noise associated with the use of a generator.
4. **Driving a motorized vehicle onto the turf area of any park is prohibited. Only hand carts/hand dollies are allowed to install or retrieve jumper.** Disturbance of grass area is prohibited.
5. **UNAUTHORIZED JUMPERS ARE SUBJECT TO CONFISCATION. CMC 12.24.070**
6. The jumper company must be in possession of a current City of Carpinteria Business License. CMC 5.04.050.
7. The jumper company must provide to the City a certificate of insurance with a minimum of \$1,000,000 liability coverage along with an Additional Insured Endorsement page naming the City of Carpinteria as an additional insured. 8. Jumper shall not interfere with the enjoyment of others at the park and be considerate of the neighbors.

**NOTE: At all parks, mega-size jumpers, dunk tanks, and jumpers with water or exterior slides (water or dry) are NOT allowed!!** Jumpers must fit in an area of 20 x 20 feet area.
