Notice is hereby given that a public hearing will be held before a regular meeting of the City Council at 5:30 p.m., or as soon thereafter as may be heard, on Tuesday, May 27, 2025, on the following matters:

1. Continuation of Carpinteria Street Lighting District No. 1 for Fiscal Year 2025-26 and hearing of written protests to the proposed improvements or to the assessment therefore in accordance with Resolution of Intention No. 6389 adopted April 28, 2025.
2. Continuation of Carpinteria Right-Of-Way Improvement District No. 3 for Fiscal Year 2025-26 and hearing of written protests to the proposed improvements or to the assessment therefore in accordance with Resolution of Intention No. 6391 adopted April 28, 2025.
3. Continuation of Carpinteria Parking and Business Improvement Area District No. 4 for Fiscal Year 2025-26 and hearing of written protests to the proposed improvement or to the assessment therefore in accordance with Resolution of Intention No. 6393 adopted April 28, 2025.
4. Continuation of the City's Winter Protection Berm Assessment District No. 5 for Fiscal Year 2025-26, and to levy and collect the assessment pursuant to the Municipal Improvement Act of 1913, Streets and Highways Code, and to order the construction of the improvement in accordance with Resolution of Intention No. 6394 adopted April 28, 2025.
