## Payment Policy

The City of Carpinteria accepts **cash, check, ACH, and credit/debit card payments** for municipal services and programs.

Local governments are permitted, but not required, to accept credit and/or debit cards as a form of payment. As a convenience to our customers, the City of Carpinteria facilitates the use of credit cards.

Effective July 1, 2024, a 4% managed service fee will be applied to all credit card purchases for municipal services and programs. This fee applies specifically to payments made to the City for programs and services and helps offset third-party payment processor fees. This fee is not revenue to the City.



## Community Development Department

The City's Community Development Department provides services to the public in the areas of construction safety, planning, housing, land use, and code enforcement. The Community Development Director, or a staff designee, will determine and calculate the fees required for each project. Some services are charged based on hourly rates and require an initial deposit. Fees for specific permits, inspections, and regulatory services are listed in the following subsections.

### Building & Planning

The Community Development Department (CDD) oversees building safety, land use, and planning activities to ensure development within the City is safe, compliant, and consistent with adopted plans and regulations. Services include building plan review, construction inspections, zoning and land use approvals, environmental and coastal permitting, and long-range planning efforts.

Fees are assessed to recover the cost of staff time, professional review, public hearings, and administrative processing required to evaluate and approve development projects. Depending on the project type, fees may be based on fixed amounts, deposits with actual cost recovery, or a combination of both. Additional costs may apply for specialized services, contract personnel, consultant services, or state-mandated requirements.
